

It is also brought to your notice that vide this Ministry letter dated 9.6.2010, it was clearly stated that for identification of suitable implementing agency(IA), DMT has to select IA preferably the District Red Cross Society or a similar autonomous/semi autonomous body of the State. The feasibility of assigning the task to the Red Cross Society located at the district may also be explored.


